# Management Team Commentary



March saw a volatile market for Gold with the metal twice testing lows around USD 1680 and bouncing back to finish the month at 1704. As we write gold has further rallied to 1745 on the back of higher than expected PPI and CPI numbers, a weaker dollar and US 10 year rates which are starting to slide. Your fund finished the month almost unchanged (+0.13%) while our benchmark rose by 3.5%. Much of this was due to our Australian holdings missing out on the strong rally in late trading on the last day of the month. At the time of writing (12 April) this has corrected itself and the fund is up by 1% versus its benchmark year to date.


We believe that the outlook over the next six months is for continuing inflationary pressure from both hard and soft commodities feeding through to final goods prices while the Fed will try to hold the bond market steady and resist any pressure to even talk about raising rates. This should provide a positive impetus for gold at a time when investor sentiment towards the metal is at bearish extremes and the valuation of gold mining equities is at multi decade lows.




#### **Market Cap Breakdown**
